A RESOLUTION

Approving and accepting a grant from the Government of the People's Republic of China in the amount of two million RMB (RMB 2,000,000) to assist the FSM in its participation in the International Horticulture Exhibition 2019, including all the terms and conditions of the assistance.

1           WHEREAS, on February 1, 2019, the Government of the  
2 People's Republic of China provided written confirmation to  
3 provide the Federated States of Micronesia with a RMB 2,000,000  
4 grant to assist the FSM in its participation in the  
5 International Horticulture Exhibition 2019; and

6           WHEREAS, section 210(2) of title 55 of the Code of the  
7 Federated States of Micronesia (Annotated), as amended,  
8 requires that for foreign financial assistance to be valid it  
9 must be approved by Congress by resolution; and

10           WHEREAS, that the Government of the Federated States of  
11 Micronesia wishes to express its appreciation to the Government  
12 of the People's Republic of China for the assistance provided  
13 to the FSM; now, therefore,

14           BE IT RESOLVED by the Twentieth Congress of the Federated  
15 States of Micronesia, Eighth Special Session, 2019, that  
16 Congress hereby approves and accepts the grant in the amount of  
17 RMB 2,000,000 from the People's Republic of China to assist the  
18 FSM in participating in the International Horticulture

1 Exhibition 2019, including all the terms and conditions  
2 thereof; and

3 BE IT FURTHER RESOLVED that certified copies of this  
4 resolution be transmitted to the President of the Federated  
5 States of Micronesia, the Secretary of the Department of  
6 Finance and Administration, the Secretary of the Department of  
7 Justice, and the Chinese Embassy in Palikir.




