A RESOLUTION

Approving the submission of the 2019 application for federal assistance to the United States Department of Health and Human Services, Centers for Disease Control and Prevention, to fund the FSM Immunization and Vaccines Preventable Disease Program and its activities in the amount of \$1,249,356 for the project period from July 01, 2019, to June 30, 2020.

1           WHEREAS, this is a cooperative agreement grant that has  
2 been utilized by the FSM Department of Health and Social  
3 Affairs in previous years in implementing the Immunization and  
4 Vaccines Preventable Disease Programs' services and activities  
5 to help continue its effort to develop, improve and maintain  
6 its public health infrastructure, help in assurance of high  
7 immunization coverage levels and low incidence of Vaccines  
8 Preventable Diseases (YPD); and

9           WHEREAS, the funding availability in this program can be  
10 of benefit to the FSM, particularly children; and

11           WHEREAS, section 210(2)(c) of title 55 of the Code of the  
12 Federated States of Micronesia (Annotated), as amended,  
13 requires prior to the submission of any first time application  
14 for foreign financial assistance it must be approved by  
15 Congress by resolution; now, therefore,

16           BE IT RESOLVED by the Twentieth Congress of the Federated  
17 States of Micronesia, Eighth Special Session, 2019, that Congress  
18 hereby approves the submission of the grant application in the

1 amount of \$1,249,356 to the U.S. Department of Health and Human  
2 Services, Centers for Disease Control and Prevention, to fund the  
3 FSM Immunization and Vaccines Preventable Disease Program; and

4 BE IT FURTHER RESOLVED that certified copies of this  
5 resolution be transmitted to the President of the Federated States  
6 of Micronesia, the Secretary of the Department of Health and  
7 Social Affairs and the United States Embassy in Kolonia.




