A BILL FOR AN ACT

To further amend title 22 of the Code of the Federated States of Micronesia (Annotated), as amended, by reinserting section 416 thereof, to correct technical errors in the 2014 F.S.M.C. (Annotated), and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. The purpose of this Act is to correct a
technical error in the codification of title 22 of the Code of
the Federated States of Micronesia (Annotated). Public Law No.
11-41 enacted section 416 of title 22; however, that section
was unintentionally omitted from the 2014 F.S.M.C. (Annotated).
This Act amends title 22 to accurately reflect the provisions
of Public Law No. 11-41.

8 Section 2. Title 22 of the Code of the Federated States 9 of Micronesia (Annotated), as amended, is hereby amended by 10 reinserting section 416 to read as follows:

11	"Section 416. Aircraft and sea vessel
12	responsibilities for overtime. Any aircraft or sea
13	vessel landing at any airport, or calling at any port
14	in the Federated States of Micronesia, shall be
15	responsible for paying to the Treasurer of the
16	Federated States of Micronesia an amount equal to the
17	actual costs to the National Government for overtime
18	accrued by the officials responsible for carrying out

1	the purpose of this title whenever such officials are
2	required to carry out their official duties relating
3	to the aircraft or sea vessel at a time outside of the
4	officials' ordinary working hours. The Secretary of
5	Economic Affairs shall determine the amount payable by
6	the aircraft or sea vessel under this section and
7	shall submit invoices to the aircraft or sea vessel
8	for payment of such amounts on a monthly basis;
9	provided, however, if an aircraft or sea vessel's
10	arrival is for one time only or is likely to occur at
11	infrequent intervals the invoice shall be made as soon
12	as possible after the arrival of the vessel or
13	aircraft, including at the time of the arrival itself
14	as may be provided by the regulations. For purposes
15	of this section, overtime means actual hours worked in
16	excess of 40 actual hours per week worked by an
17	official or employee of the National Government."
18	Section 3. This act shall become law upon approval by the
19	President of the Federated States of Micronesia or upon its
20	becoming law without such approval.
