A BILL FOR AN ACT

To further amend Public Law No. 16-18, as amended by Public Laws Nos. 16-24, 16-32, 16-39, 16-45, 16-54, 16-67, 17-04, 17-14, 17-26, 17-39, 17-65, 18-27, 18-47, 18-80, 19-13, 19-108, 20-34, 20-109, 21-26 and 21-108, by amending section 2 thereof, to change the allottee and lapse date of certain funds previously appropriated therein, for the purpose of funding social programs and projects in Chuuk state, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 2 of Public Law No. 16-18, as amended
by Public Laws Nos. 16-24, 17-14, 17-39, 18-27, 18-80, 19-13,
19-108, 20-109 and 21-26, is hereby further amended to read as
follows:

5 "Section 2. Allotment and management of funds and lapse 6 date. All funds appropriated by this act shall be 7 allotted, managed, administered and accounted for in accordance with applicable laws, including, but not 8 9 limited to, the Financial Management Act of 1979. The allottee shall be responsible for ensuring that these 10 11 funds, or so much thereof as may be necessary, are used 12 solely for the purpose specified in this act, and that 13 no obligations are incurred in excess of the sum appropriated. 14 The allottee of the funds appropriated 15 under subsections 1 and 2 of section 1 of this act shall be the President of the Federated States of Micronesia 16 or his designee, EXCEPT THAT the allottee of funds 17

2	(f), (g), (j), (n(i)), (p), (q) and (r) of this act
3	shall be the Mayor of Lelu Municipal Government; the
4	allottee of funds appropriated under sections 1(4)(a)[ $_{ au}$
5	<del>l(4)(c)</del> ] and l(4)(f) shall be the Governor of Chuuk
6	State or his designee; the allottee of funds
7	appropriated under section 1(4)(b) shall be the Mortlock
8	Islands Development Authority; the allottee of funds
9	appropriated under section 1(4(c) of this act shall be
10	the Mayor of Weno Municipal Government or his designee;
11	the allottee of funds appropriated under section 1(4)(d)
12	shall be the Faichuk Development Authority; the allottee
13	of funds appropriated under section 1(4)(e) shall be the
14	Southern Namoneas Development Authority. The allottee
15	of funds appropriated under section 1(1) of this act
16	shall be the Governor of the State of Yap. The
17	authority of the allottee to obligate funds appropriated
18	by this act shall lapse on September 30, [ $\frac{2020}{2022}$ ."
