A BILL FOR AN ACT

To appropriate the sum of \$1,000,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2020, for the purpose of funding Airport Facilities Improvement in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. The sum of \$1,000,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2020, for the purpose of funding Airport Facilities Improvement in each of the states. The funds appropriated under this section shall be apportioned as follows:

The authority of the allottee to 21 22 obligate funds appropriated by this act shall lapse on September 30, 23 2022.
