AN ACT

To further amend Public Law No. 16-49, as amended by Public Laws Nos. 16-68, 16-76, 17-06, 17-10, 17-23, 17-30, 17-32, 17-45, 17-82, 17-85, 18-28, 18-45, 18-59, 18-86, 19-11, 19-106, 19-110 and 20-108 by amending section 6 thereof, for the purpose of changing the lapse date of certain funds previously appropriated therein, to fund public projects and social programs in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 6 of Public Law No. 16-49, as amended by 1 Public Laws Nos. 17-10, 17-45, 17-85, 18-28, 18-86, 19-11, 19-106, 3 19-110 and 20-108, is further hereby amended to read as follows: 4 "Section 6. Allotment and management of funds and lapse 5 date. All funds appropriated by this act shall be 6 allotted, managed, administered and accounted for in 7 accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. 8 The 9 allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used 10 11 solely for the purpose specified in this act, and that no 12 obligations are incurred in excess of the sum 13 appropriated. The allottee of funds appropriated under sections 2 and 4 of this act shall be the President of 14 15 the Federated States of Micronesia or his designee; PROVIDED THAT the allottee of funds appropriated under 16 17 section 4(1)(b) shall be the Pohnpei Transportation

1 Authority and the allottee of the funds appropriated 2 under section 4(1)(j) shall be the Mayor of Kolonia Town Government. The allottee of funds appropriated under 3 section 3 of this act shall be the Governor of Yap State. 4 5 The allottee of funds appropriated under subsections 5(1), 5(3), 5(6) and 5(7) of this act shall be the 6 7 Governor of Chuuk State or his designee. The allottee of funds appropriated under subsection 5(2) of this act 8 shall be the Mortlock Islands Development Authority 9 10 (MIDA). The allottee of funds appropriated under subsection 5(4) of this act shall be the Southern 11 12 Namoneas Development Authority. The allottee of funds appropriated under subsection 5(5) of this act shall be 13 14 the Faichuk Development Authority. The funds appropriated by this act shall lapse on September 30, 15 2020." 16 17 18 19 20 21 22 23 24 25
