## AN ACT

To further amend Public Law No. 19-54, as amended by Public Laws Nos. 19-62, 19-75, 19-79, 19-99, 19-119, 20-04, 20-56, 20-82, 20-127 and 21-20, by amending sections 2 and 6 thereof, to change the use, allottee and lapse date of funds previously appropriated therein, to fund public projects and social programs for Yap and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 2 of Public Law No. 19-54 is hereby

4	Section 2. Section 6 of Public Law No. 19-54, as amended by
5	Public Laws Nos. 19-62, 19-75, 19-99, 19-129, 20-04, 20-127 and
6	21-20, is hereby further amended to read as follows:
7	"Section 6. Allotment and management of funds and lapse
8	date. All fund appropriated by this act shall be
9	allotted, managed, administered and accounted for in
10	accordance with applicable laws including, but not
11	limited to, the applicable laws, including, but not
12	limited to, the Financial Management Act of 1979. The
13	allottee shall be responsible for ensuring that these
14	funds, or so much thereof as may be necessary, are used
15	solely for the purpose specified in this act, and that
16	no obligations are incurred in excess of the sum
17	appropriated. The allottee of the funds appropriated
18	under section 2 of this act shall be the Governor of Yap
19	State. The allottee of funds appropriated under
20	sections 3 and 4 of this act shall be the President of
21	the Federated States of Micronesia or his designee;
22	PROVIDED THAT, the allottee of funds appropriated under
23	subsections 3(a), (b), (c), (d), (e), (f), (g), (h),
24	(t), $(u)$ , $(v)$ , $(ag)$ , $(ar)$ and $(as)$ of this act shall be
25	the Mayor of Utwe Municipal Government or his designee;

1	the allottee of funds appropriated under subsections
2	3(k), (w), (x), (y), (z), (aa), (ab), (ac), (ad), (ae),
3	(af), (ah), (ai), (aj), (ak), (al), (am), (an), (ao),
4	(ap) and (aq) of this act shall be the Mayor of Tafunsak
5	Municipal Government or his designee; the allottee of
6	funds appropriate under subsections ((1)(a), (b), (c),
7	(e), (f), and 4(2) shall be the Secretary of the
8	Department of Transportation, Communications and
9	Infrastructure or his designee; he allottee of funds
10	appropriated under subsections 4(1)(d), 4(3)(b),
11	4(3)(d), 4(3)(e), 4(3)(h), 4(3)(k) and 4(3)(1) shall be
12	the Pohnpei Transportation Authority (PTA). The
13	allottee of funds appropriated under subsections 5(1)
14	and 5(6) of this act shall be the Governor of Chuuk
15	State or his designee. The allottee of funds
16	appropriated under subsection 5(2) of this act shall be
17	the Mortlock Islands Development Authority. The
18	allottee of funds appropriated under subsection 5(3) of
19	this act shall be the Mayor of Weno Municipal Government
20	or his designee. The allottee of funds appropriated
21	under subsection 5(4) of this act shall be the Southern
22	Namoneas Development Authority. The allottee of funds
23	appropriated under subsection 5(5) of this act shall be
24	the Faichuk Development Authority. The authority of the
25	allottee to obligate funds appropriated by this act

1	shall lapse on September 30, 2022."	
2	Section 3. This act shall become law upon approval by	the
3	President of the Federated States of Micronesia or upon its	
4	becoming law without such approval.
