## AN ACT

To further amend Public Law No. 20-155, as amended by Public Laws Nos. 20-177, 20-188, 21-61 and 21-88, by amending section 6 thereof, for the purpose of changing the allottee of certain funds previously appropriated therein, to fund public projects and social programs for the people of Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 6 of Public Law No. 20-155, as amended by
- 2 Public Laws Nos. 20-177 and 20-188, is hereby further amended to
- 3 read as follows:

4 "Section 6. Allotment and management of funds and lapse 5 date. All funds appropriated by this act shall be allotted, managed, administered and accounted for in 6 7 accordance with applicable laws, including, but not 8 limited to, the Financial Management Act of 1979. The allottee shall be responsible for ensuring that these 9 10 funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that 11 12 no obligations are incurred in excess of the sum 13 The allottee of the funds appropriated under section 2 of this act shall be the Governor of Yap 14 15 State or his designee; PROVIDED THAT the allottee of 16 funds appropriated under subsection 2(c) of this act shall be the Speaker of the Congress of the Federated 17 18 States of Micronesia or his designee. The allottee of

funds appropriated under section 3 of this act shall be
the Governor of Kosrae State or his designee. The
allottee of funds appropriated under section 4 of this
act shall be the President of the Federated States of
Micronesia or his designee; PROVIDED THAT the allottee
of funds appropriated under subsections 4(1)(c) of this
act shall be the Governor of Pohnpei State or his
designee; the allottee of funds appropriated under
subsections 4(2)(a) and 4(2)(b) of this act shall be the
Pohnpei Transportation Authority; the allottee of funds
appropriated under subsections 4(2)(c), 4(2)(d) and
4(2)(e) of this act shall be the Secretary of the
Department of Transportation, Communications and
Infrastructure or his designee; the allottee of funds
appropriated under subsections $4(3)(a)$ , $4(3)(e)$ and
4(3)(f) of this act shall be the Luhken Moanlap of
Kitti; the allottee of funds appropriated under
subsection 4(3)(g) of this act shall be the Secretary of
the Department of Education or his designee. The
allottee of funds appropriated under subsection 4(3)(d)
of this act shall be the Secretary of the Department of
Resources and Development or his designee. The allottee
of the funds appropriated under subsections 5(1) and
5(6) of this act shall be the Governor of Chuuk State or
his designee; the allottee of the funds appropriated

1	under subsection 5(2) of this act shall be the Mortlocks
2	Island Development Authority (MIDA); the allottee of
3	funds appropriated under subsection 5(3) of this act
4	shall be the Mayor of Weno Municipal Government or his
5	designee; the allottee of the funds appropriated under
6	subsection 5(4) of this act shall be the Southern
7	Namoneas Development Authority; the allottee of the
8	funds appropriated under subsection 5(5) of this act
9	shall be the Faichuk Development Authority. The
10	authority of the allottee to obligate funds appropriated
11	by this act shall lapse on September 30, 2021."
12	Section 2. This act shall become law upon approval by the
13	President of the Federated States of Micronesia or upon its
14	becoming law without such approval.
