## AN ACT

To further amend Public Law No. 19-121, as amended by Public Laws Nos. 19-130, 19-142, 19-145, 19-158, 20-09, 20-22, 20-51, 20-59, 20-70, 20-123, 20-162 and 20-170, by amending section 6 thereof, to change the lapse date of certain funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of the states of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 19-121, as amended by

Public Laws Nos. 19-130, 19-142, 20-09, 20-70, 20-123, 20-162 and

3 20-170, is hereby further amended to read as follows:

4 "Section 6. Allotment and management of funds and lapse 5 date. All funds appropriated by this act shall be 6 allotted, managed, administered and accounted for in 7 accordance with applicable laws, including, but not 8 limited to, the Financial Management Act of 1979. The 9 allottee shall be responsible for ensuring that these 10 funds, or so much thereof as may be necessary, are used 11 solely for the purpose specified in this act, and that 12 no obligations are incurred in excess of the sum appropriated. The allottee of the funds appropriated 13 14 under section 2 of this act shall be the Governor of Yap 15 State; PROVIDED THAT, the allottee of funds appropriated 16 under section 2(k) shall be the President of the 17 Federated States of Micronesia. The allottee of funds

1	appropriated under sections 3 and 4 of this act shall be
2	the President of the Federated States of Micronesia or
3	his designee; PROVIDED THAT the allottee of funds
4	appropriated under subsections 3(a) through 3(z) shall
5	be the Mayor of Tafunsak Municipal Government; the
6	allottee of funds appropriated under subsections 3(aa) -
7	3(all) shall be the Mayor of Lelu Town Government, or
8	his designee; the allottee of funds appropriated under
9	subsection 4(1)(a) of this act shall be the Governor of
10	Pohnpei State or his designee; the allottee of funds
11	appropriated under subsections $4(1)(1)$ , $4(3)(a)$ , $4(3)(f)$
12	and 4(3)(i) of this act shall be the Pohnpei
13	Transportation Authority (PTA); the allottee of funds
14	appropriated under subsections 4(2)(a), 4(2)(d),
15	4(2)(e), $4(2)(f)$ , $4(2(g)$ , $4(2)(h)$ , $4,(2)(i)$ , $4(2)(j)$ ,
16	4(2)(k), $4(2)(1)$ and $4(2)(m)$ shall be the Secretary of
17	the Department of Transportation, Communications and
18	Infrastructure or his designee; the allottee of funds
19	appropriated under subsection $4(2)(b)$ shall be the
20	Pohnpei Utility Corporation (PUC); the allottee of funds
21	appropriated under subsection $4(2)(c)$ shall be the
22	Office of Fisheries, Pohnpei State; the allottee of
23	funds appropriated under subsection 4(2)(n) shall be the
24	Secretary of the Department of Education or his
25	designee; the allottee of funds appropriated under

1	subsection 4(3)(b) shall be the Pohnpei State Public
2	Safety; the allottee of funds appropriated under
3	subsections $4(3)(c)$ and $4(3(e))$ of this act shall be the
4	Meninkeder of Madolenihmw; allottee of funds
5	appropriated under subsections $4(3)(d)$ and $4(3)(m)$ shall
6	be the Luhkenmoanlap of Kitti. The allottee of funds
7	appropriated under subsections $5(1)$ , $5(3)$ and $5(6)$ of
8	this act shall be the Governor of Chuuk State or his
9	designee. The allottee of funds appropriated under
10	subsection 5(2) of this act shall be the Mortlock
11	Islands Development Authority. The allottee of funds
12	appropriated under subsection 5(4) of this act shall be
13	the Southern Namoneas Development Authority. The
14	allottee of funds appropriated under subsection 5(5) of
15	this act shall be the Faichuk Development Authority.
16	The authority of the allottee to obligate funds
17	appropriated by this act shall lapse on September 30,
18	2020."
