AN ACT

To further amend title 22 of the Code of the Federated States of Micronesia (Annotated), as amended, by reinserting section 416 thereof, to correct technical errors in the 2014 F.S.M.C. (Annotated), and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. The purpose of this Act is to correct a 2 technical error in the codification of title 22 of the Code of the Federated States of Micronesia (Annotated). Public Law No. 3 4 11-41 enacted section 416 of title 22; however, that section was unintentionally omitted from the 2014 F.S.M.C. (Annotated). 5 This Act amends title 22 to accurately reflect the provisions 6 7 of Public Law No. 11-41.

Section 2. Title 22 of the Code of the Federated States 8 of Micronesia (Annotated), as amended, is hereby amended by 9 reinserting section 416 to read as follows: 10

11 "Section 416. Aircraft and sea vessel responsibilities 12 for overtime. Any aircraft or sea vessel landing at any airport, or calling at any port in the Federated 13 States of Micronesia, shall be responsible for paying 14 to the Treasurer of the Federated States of Micronesia 15 16 an amount equal to the actual costs to the National 17 Government for overtime accrued by the officials responsible for carrying out the purpose of this title 18

1	whenever such officials are required to carry out their
2	official duties relating to the aircraft or sea vessel
3	at a time outside of the officials' ordinary working
4	hours. The Secretary of Economic Affairs shall
5	determine the amount payable by the aircraft or sea
6	vessel under this section and shall submit invoices to
7	the aircraft or sea vessel for payment of such amounts
8	on a monthly basis; provided, however, if an aircraft
9	or sea vessel's arrival is for one time only or is
10	likely to occur at infrequent intervals the invoice
11	shall be made as soon as possible after the arrival of
12	the vessel or aircraft, including at the time of the
13	arrival itself as may be provided by the regulations.
14	For purposes of this section, overtime means actual
15	hours worked in excess of 40 actual hours per week
16	worked by an official or employee of the National
17	Government."
