CONGRESSIONAL BILL NO. 21-70

AN ACT

To further amend Public Law No. 20-31, as amended by Public Laws Nos. 20-41, 20-50, 20-77, 20-113 and 21-24, by amending section 3 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs for the people of Kosrae State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 20-31, as amended
2 by Public Laws Nos. 20-41 and 20-113, is hereby further amended
3 to read as follows:


