AN ACT

To further amend Public Law No. 19-124, as amended by Public Laws Nos. 19-133, 19-140, 19-150, 20-05, 20-15 20-33, 20-48, 20-63 20-156 and 20-175 by amending section 5 thereof, to change the use of certain funds previously appropriated therein, to fund priority infrastructure projects and other programs in the state of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 5 of Public Law No. 19-124, as amended by
