AN ACT

To appropriate the sum of \$100,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2020, for the purpose of funding relief efforts in Japan due to damage caused by recent typhoons, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 The sum of \$100,000, or so much thereof as may Section 1.
- be necessary, is hereby appropriated from the General Fund of
- the Federated States of Micronesia for the fiscal year ending
- September 30, 2020, for the purpose of funding relief efforts
- in Japan due to damage caused by recent typhoons.
- appropriated under this section shall be apportioned as
- 7 follows:
- Japan Typhoon Relief..... 100,000 1.
- Section 2. Allotment and management of funds and lapse 9
- date. All funds appropriated by this act shall be allotted, 10
- managed, administered and accounted for in accordance with 11
- applicable laws, including, but not limited to, the Financial 12
- Management Act of 1979. The allottee shall be responsible for 13
- ensuring that these funds, or so much thereof as may be 14
- necessary, are used solely for the purpose specified in this 15
- act, and that no obligations are incurred in excess of the sum 16
- appropriated. The allottee of the funds appropriated under 17
- 18 section 1 of this act shall be the President of the Federated

1	States of Micronesia or his designee. The authority of the
2	allottee to obligate such funds shall lapse on September 30,
3	2020 and any unallotted funds will revert back to the General
4	Fund.
5	Section 3. This act shall become law upon approval by the
6	President of the Federated States of Micronesia or upon its
7	becoming law without such approval.
