Congressional Act No. 21-05, entitled: "AN ACT TO FURTHER AMEND SECTION 204 OF TITLE 2 OF THE CODE OF THE FEDERATED STATES OF MICRONESIA (ANNOTATED), AS AMENDED BY PUBLIC LAWS NOS. 19-29, 19-63 AND 20-47, TO REMOVE THE DIVISION OF PERSONNEL FROM THE OFFICE OF THE PRESIDENT, AND CREATE A SEPARATE OFFICE OF PERSONNEL UNDER THIS SECTION, AND OTHER PURPOSES."

As its title suggests, this act creates a separate Office of Personnel, and I thank the 21st Congress for its initiative in passing this act.



CONGRESSIONAL BILL NO. 21-18

AN ACT

To further amend section 204 of title 2 of the Code of the Federated States of Micronesia (Annotated), as amended by Public Laws Nos. 19-29, 19-63 and 20-47, to remove the Division of Personnel from the Office of the President, and create a separate Office of Personnel under this section, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 204 of title 2 of the Code of the
2 Federated States of Micronesia (Annotated), as amended by Public
3 Laws Nos. 19-29, 19-63 and 20-47, is hereby further amended, to
4 read as follows:

5 "Section 204. Other Executive Offices

6 There shall be the following executive offices:

7 (1) Office of the Public Defender;

8 (2) Office of National Archives, Culture and

9 Historic Preservation;

10 (3) Office of Veteran's Affairs; and

11 (4) Office of Personnel."


