CONGRESSIONAL BILL NO. 21-20

AN ACT

To further amend sections 4 and 6 of Public Law No. 20-141, as amended by Public Laws Nos. 20-145, 20-163, 20-164 and 20-190, to change the use and allottee of funds previously appropriated therein, for the purpose of funding priority infrastructure projects and other projects and programs in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 20-141, as amended
2 by Public Laws Nos. 20-163 and 20-190, is hereby further amended
3 to read as follows:

4 "Section 4. Of the 12,800,000 appropriated

6 priority infrastructure projects and other projects and
7 programs in the state of Pohnpei.

23 Section 2. Section 6 of Public Law No. 20-141, as
 24 amended by Public Laws Nos. 20-163 and 20-190, is hereby
 25 further amended to read as follows:

1 "Section 6. Allotment and management of funds and
2 lapse date. All funds appropriated by this act shall
3 be allotted, managed, administered and accounted for in
4 accordance with applicable laws, including, but not
5 limited to, the Financial Management Act of 1979. The
6 allottee shall be responsible for ensuring that these
7 funds, or so much thereof as may be necessary, are used
8 solely for the purpose specified in this act, and that
9 no obligations are incurred in excess of the sum
10 appropriated. The allottee of the funds appropriated
11 under section 2 of this act shall be the Governor of
12 Yap State or his designee. The allottee of the funds
13 appropriated under sections 3 and 4 of this act shall
14 be the President of the Federated States of Micronesia
15 or his designee; PROVIDED THAT, the allottee of funds
16 appropriated under subsections 3(a), 3(b), 3(c), 3(e),
17 3(f), 3(g), 3(h), 3(j), 3(k), 3(l), 3(m), 3(n), 3(o),
18 3(p), 3(q), 3(s), 3(t), 3(u), 3(v), 3(w), 3(x), 3(y),
19 3(z) and 3(a3) to 3(a10) of this act shall be the Mayor
20 of Lelu Town Government or his designee; the allottee
21 of funds appropriated under subsections 3(d), 3(i),
22 3(r), 3(a2) and 3(a11) to 3(a25) of this act shall be
23 the Mayor of Tafunsak Municipal Government or his
24 designee; the allottee of funds appropriated under
25 subsection 3(a26) is the Secretary of the FSM

1 Department of Education or his designee; the allottee
2 of funds appropriated under subsection 4(1)(v) of this
3 act shall be the Meninkeder lapalap of Madolenihmw
4 Municipal Government or his designee; the allottee of
5 funds appropriated under subsection 4(1)(w) of this act
6 shall be the Chief Minister of U Municipal Government
7 or his designee; the allottee of funds appropriated
8 under subsections 4(1)(x) and 4(4)(n) of this act shall
9 be the District Administrator of Nett Municipal
10 Government or his designee; the allottee of funds
11 appropriated under subsection 4(1)(y) of this act shall
12 be the Luhken Menlap of Kitti Municipal Government or
13 his designee; the allottee of funds appropriated under
14 subsection 4(1)(z) of this act shall be the Chief
15 Magistrate of Sokehs Municipal Government or his
16 designee; the allottee of funds appropriated under
17 subsections 4(2)(a) to 4(2)(s) and 4(2)(ab) of this act
18 shall be the Pohnpei Transportation Authority (PTA);
19 the allottee of funds appropriated under subsection
20 4(3)(n) of this act shall be the Secretary of the
21 Department of Health and Social Affairs or her
22 designee, the allottee of funds appropriated under
23 subsections 4(2)(h), 4(2)(q), 4(2)(u), 4(2)(ac),
24 4(2)(v), 4(2)(w), 4(2)(x), and 4(2)(z) of this act
25 shall be the Secretary of the Department of

1 Transportation, Communications and Infrastructure or
2 his designee; the allottee of funds appropriated under
3 subsection 4(2)(y) of this act shall be the Pohnpei
4 Port Authority; the allottee of funds appropriated
5 under subsection 4(2)(aa) of this act shall be the
6 Secretary of the Department of Resources and
7 Development or his designee; the allottee of fund
8 appropriated under subsections 4(1)(a2) and 4(4)(l) of
9 this act shall be the Mayor of Pingelap Municipal
10 Government; the allottee of funds appropriated under
11 subsections 4(1)(a1) and 4(4)(m) of this act shall be
12 the Chief Magistrate of Mwoakilloa Municipal
13 Government; the allottee of funds appropriated under
14 subsection 4(1)(a3) of this act shall be the Luhken
15 Kolwof of Sapuwafik Municipal Government; the allottee
16 of funds appropriated under subsection 4(1)(a4) of this
17 act shall be the Mayor of Nukuoro Municipal Government;
18 the allottee of funds appropriated under subsection
19 4(1)(a5) of this act shall be the Chief Magistrate of
20 Kapingamarangi Municipal Government; The allottee of
21 funds appropriated 4(3)(a5) shall be the Secretary of
22 the Department of Health and Social Affairs. The
23 allottee of the funds appropriated sections 5 of this
24 act shall be the Governor of Chuuk State or his
25 designee; PROVIDED THAT, the allottee of funds

6 Section 3. This act shall become law upon approval by the
7 President of the Federated States of Micronesia or upon its
8 becoming law without such approval.
