AN ACT

To further amend Public Law No. 20-178, as amended by Public Laws Nos. 21-01, 21-07, 21-36, 21-53, 21-56, 21-102, 21-115, 21-137 and 21-165, by amending sections 3 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs for the people of Kosrae State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

(MIDA); the allottee of funds appropriated under
subsection 5(3) of this act shall be the Mayor of Weno

2	the funds appropriated under subsection 5(4) of this act
3	shall be the Southern Namoneas Development Authority;
4	the allottee of the funds appropriated under subsection
5	5(5) of this act shall be the Faichuk Development
6	Authority. The authority of the allottee to obligate
7	funds appropriated by this act shall lapse on September
8	30, 2022."
9	Section 3. This act shall become law upon approval by the
10	President of the Federated States of Micronesia or upon its
11	becoming law without such approval.
