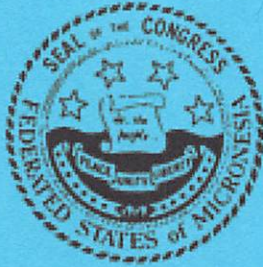

AN ACT

To further amend Public Law No. 19-124, as amended by Public Laws Nos. 19-133, 19-140, 19-150, 20-05, 20-15, 20-33, 20-48, 20-63, 20-71, 20-156, 20-175, 21-22, 21-52 and 21-146, by amending sections 4 and 6 thereof, to change the use and allottee of certain funds previously appropriated therein, to fund priority infrastructure projects and other programs in the states of Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 19-124, as amended
2 by Public Laws Nos. 19-133, 19-140, 20-05, 20-15, 20-33, 20-48,
3 20-63 and 20-71, is hereby further amended to read as follows:

4 "Section 4. Of the \$11,300,000 appropriated under this
5 act, \$3,000,000 shall be apportioned for priority
6 infrastructure projects and other programs in the state
7 of Pohnpei.

23	Section 2. Section 6 of Public Law No. 19-124, as amended by	
24	Public Laws Nos. 19-133, 19-140, 20-05, 20-15, 20-33, 20-48, 20-63,	
25	20-156, 21-22 and 21-146, is hereby further amended to read as	

1 follows:

2 "Section 6. Allotment and management of funds and lapse
3 date. All funds appropriated by this act shall be
4 allotted, managed, administered and accounted for in
5 accordance with applicable laws, including, but not
6 limited to, the Financial Management Act of 1979. The
7 allottee shall be responsible for ensuring that these
8 funds, or so much thereof as may be necessary, are used
9 solely for the purpose specified in this act, and that no
10 obligations are incurred in excess of the sum
11 appropriated. The allottee of the funds appropriated
12 under section 2 of this act shall be the Governor of the
13 State of Yap or his designee. The allottee of the funds
14 appropriated under sections 3 and 4 of this act shall be
15 the President of the Federated States of Micronesia or his
16 designee; PROVIDED THAT, the allottee of funds
17 appropriated under subsections 3(1)(a) and 3(1)(b) of this
18 act shall be the Governor of Kosrae State or his designee,
19 the allottee of funds appropriated under subsections
20 4(1)(c) through 4(1)(o), 4(2)(f), 4(3)(k), 4(3)(q),
21 4(3)(s), 4(3)(af), 4(4)(b), 4(4)(d) and 4(4)(f), shall be
22 the Pohnpei Transportation Authority (PTA); the allottee
23 of funds appropriated under subsections 4(1)(a), 4(1)(b),
24 4(1)(f), 4(2)(c), 4(2)(d), 4(2)(e), 4(2)(g), 4(2)(h),
25 4(2)(i), 4(2)(j) and 4(3)(x) shall be the Secretary of the

1 Department of Transportation, Communications and
2 Infrastructure or his designee; the allottee of funds
3 appropriated under subsections 4(3)(f), 4(3)(i), 4(3)(q)
4 4(3)(w) and 4(3)(aa) of this act shall be the Luhk en
5 Moanlap of Kitti, the allottee of funds appropriated under
6 subsection 4(3)(ad) of this act shall be the Chief Justice
7 of Madolenihmw or his designee, the allottee of funds
8 appropriated under subsection 4(3)(ae) of this act shall
9 be the Chief Justice of Kitti or his designee. The
10 allottee of the funds appropriated under subsections
11 4(3)(ak) and 4(3)(ao) of this act shall be the Vice
12 President of the Federated States of Micronesia or his
13 designee; the allottee of funds appropriate under
14 subsection 4(3)(al) of this act shall be the Meninkeder
15 lapalap of madolenihmw Municipal Government or his
16 designee. The allottee of funds appr5(1)(2) and 5(1)(7)
17 of this act shall be the Governor of Chuuk State or his
18 designee; the allottee of funds appropriated under
19 subsection 5(1)(3) of this act shall be the Mortlock
20 Islands Development Authority (MIDA); the allottee of
21 funds appropriated under subsections 5(1)(1) and 5(1)(4)
22 of this act shall be the Mayor of Weno Municipal
23 Government or his designee; EXCEPT THAT the allottee of
24 funds appropriated under subsection 5(1)(m) of this act
25 shall be the FSM Telecommunication Corporation; the

1 allottee of funds appropriated under subsection 5(1)(5) of
2 this act shall be the Southern Namoneas Development
3 Authority (SNDA); the allottee of funds appropriated under
4 subsection 5(1)(6) of this act shall be the Faichuk
5 Development Authority. The authority of the allottee to
6 obligate funds appropriated by this act shall lapse on
7 September 30, 2022."

8 Section 3. This act shall become law upon approval by the
9 President of the Federated States of Micronesia or upon its
10 becoming law without such approval.
