AN ACT

To appropriate the sum of \$8,400,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2021, for the purpose of funding priority infrastructure projects and other public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$8,400,000, or so much thereof as may
2 be necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending
4 September 30, 2021, for the purpose of funding priority
5 infrastructure projects and other public projects and social
6 programs for the people of Yap, Kosrae, Pohnpei and Chuuk states.
7 The funds appropriated under this section shall be apportioned as
8 follows:

9 Section 2. Of the \$8,400,000 appropriated under this act,

11 projects and other public projects and social programs for the

15 Section 6. Allotment and management of funds and lapse date.

16 All funds appropriated by this act shall be allotted, managed,

17 administered and accounted for in accordance with applicable laws,

18 including, but not limited to, the Financial Management Act of

19 1979. The allottee shall be responsible for ensuring that these

20 funds, or so much thereof as may be necessary, are used solely for

21 the purpose specified in this act, and that no obligations are

22 incurred in excess of the sum appropriated. The allottee of the

23 funds appropriated under section 2 of this act shall be the

24 Governor of Yap State or his designee. The allottee of funds


25 appropriated under sections 3 and 4 of this act shall be the

1 President of the Federated States of Micronesia or his designee;
2 PROVIDED THAT the allottee of funds appropriated under subsection
3 3(1) of this act shall be the Governor of Kosrae State or his
4 designee; the allottee of funds appropriated under subsection 3(2)
5 of this act shall be the Mayor of Lelu Town Government or his
6 designee; the allottee of funds appropriated under subsections
7 4(1) and 4(2) of this act shall be the Secretary of the Department
8 of Transportation, Communications and Infrastructure or his
9 designee; EXCEPT THAT the allottee of funds appropriated under
10 subsections 4(2)(a), 4(2)(b), 4(2)(c), 4(2)(e), 4(2)(h), 4(2)(i),
11 4(2)(j), and 4(2)(k) of this act shall be the Pohnpei
12 Transportation Authority; the allottee of funds appropriated under
13 subsection 4(2)(d) of this act shall be the President of the COM-
14 FSM Institute. The allottee of funds appropriated under
15 subsections 4(3)(a), 4(3)(b), 4(3)(i) and 4(3)(t) of this act
16 shall be the Pohnpei Transportation Authority; the allottee of
17 funds appropriated under subsections 4(3)(c), 4(3)(d), 4(3)(e),
18 4(3)(f), 4(3)(g), 4(3)(h), 4(3)(j), 4(3)(k), 4(3)(l), 4(3)(m) and
19 4(3)(o) of this act shall be the Meninkeder of Madolenihmw; the
20 allottee of funds appropriated under subsections 4(3)(n) and
21 4(3)(q) of this act shall be the Secretary of the Department of
22 Health and Social Affairs or his designee; the allottee of funds
23 appropriated under subsections 4(3)(p), 4(3)(r) and 4(3)(s) of
24 this act shall be the Vice President of the Federated States of
25 Micronesia; The allottee of the funds appropriated under

1 subsections 5(1) and 5(6) of this act shall be the Governor of
2 Chuuk State or his designee; the allottee of the funds
3 appropriated under subsection 5(2) of this act shall be the
4 Mortlocks Island Development Authority (MIDA); the allottee of
5 funds appropriated under subsection 5(3) of this act shall be the
6 Mayor of Weno Municipal Government or his designee the allottee of
7 the funds appropriated under subsection 5(4) of this act shall be
8 the Southern Namoneas Development Authority; the allottee of the
9 funds appropriated under subsection 5(5) of this act shall be the
10 Faichuk Development Authority. The authority of the allottee to
11 obligate funds appropriated by this act shall lapse on September
12 30, 2023.

13 Section 7. This act shall become law upon approval by the
14 President of the Federated States of Micronesia or upon its
15 becoming law without such approval.
