AN ACT

To amend Public Law No. 19-89, as amended by Public Laws Nos. 19-94, 19-127, 19-151, 19-159, 20-06, 20-32 and 20-136, by amending section 6 thereof, to change the lapse date of funds previously appropriated therein, for the purpose of funding public projects and social programs in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 6 of Public Law No. 19-89, as
- 2 amended by Public Laws Nos. 19-94, 19-127, 20-06 and 20-136,
- 3 is hereby further amended to read as follows:
- Allotment and management of funds and "Section 6. 4 lapse date. All funds appropriated by this act shall 5 be allotted, managed, administered and accounted for 6 in accordance with applicable laws, including, but not 7 limited to, the Financial Management Act of 1979. The 8 allottee shall be responsible for ensuring that these 9 funds, or so much thereof as may be necessary, are 10 used solely for the purpose specified in this act, and 11 that no obligations are incurred in excess of the sum 12 The allottee of the funds appropriated appropriated. 13 under section 2 of this act shall be the Governor of 14 Yap State; PROVIDED THAT, the allottee of funds 15 appropriated under subsection 2(b) of this act shall 16 be the President of the COM-FSM. The allottee of 17 funds appropriated under sections 3 and 4 of this act 18

shall be the President of the Federated States of
Micronesia or his designee; PROVIDED THAT, the
allottee of funds appropriated under subsections 3(a),
3(b), 3(c), 3(d), 3(e) 3(f), 3(g), 3(h), 3(l) and 3(m)
shall be the Mayor of Utwe Municipal Government or his
designee; the allottee of funds appropriated under
subsections $3(i)$, $3(j)$, $3(k)$, $3(p)$ and $3(q)$ shall be
the Mayor of Tafunsak Municipal Government; the
allottee of funds appropriated under subsection
4(2)(c) shall be the Secretary of the FSM Department
of Education or her designee; the allottee of funds
appropriated under subsections 4(2)(a), 4(2)(b),
4(2)(d), 4(2)(e), 4(2)(f), 4(4)(a), 4(4)(b), 4(4)(c),
4(4)(d) and $4(4)(e)$ shall be the Secretary of the
Department of Transportation, Communications and
Infrastructure or his designee; the allottee of funds
appropriated under subsections 4(3)(a) and 4(3)(b)
shall be the Pohnpei Transportation Authority; the
allottee of funds appropriated under subsection
4(4)(f) shall be the Pohnpei Utility Corporation. The
allottee of funds appropriated under subsections 5(1),
5(3), $5(4)(e)$ and $5(6)$ of this act shall be the
Governor of Chuuk State or his designee. The allottee
of funds appropriated under subsection 5(2) of this
act shall be the Mortlock Islands Development

1	Authority. The allottee of funds appropriated, under
2	subsection 5(4) of this act shall be the Southern
3	Namoneas Development Authority. The allottee of funds
4	appropriated under subsection 5(5) of this act shall
5	be the Faichuk Development Authority. The authority
6	of the allottee to obligate funds appropriated by this
7	act shall lapse on September 30, 2020."
8	Section 2. This act shall become law upon approval by the
9	President of the Federated States of Micronesia or upon its
10	becoming law without such approval.
