Expressing the sincere condolences and sadness of the Twenty-First Congress of the Federated States of Micronesia to the family of the late Honorable Camillo Noket, Chief Justice of the Chuuk State Supreme Court, at his passing on May 4, 2020.

- 1 WHEREAS, the late Honorable Camillo Noket, age 76, was born
- on July 16, 1943, in Weno, Chuuk, and passed away on May 4,
- 3 2020; and
- WHEREAS, the late Honorable Camillo Noket attended Xavier
- 5 High School from 1960-1963; and
- 6 WHEREAS, the late Honorable Camillo Noket attended the
- 7 University of Guam from 1963-1964; and
- 8 WHEREAS, in 1980, the late Honorable Camillo Noket was the
- 9 first Micronesian to pass the FSM bar without formal attendance
- 10 at a law school; and
- 11 WHEREAS, the late Honorable Camillo Noket was a member of
- 12 the Truk State Legislature from 1968-1970 and a co-author of the
- 13 Truk State Charter; and
- 14 WHEREAS, in 1970, the late Honorable Camillo Noket was the
- 15 Chairman of the Truk Fishing Authority, the Chairman of the Truk
- 16 State Foreign Investment Board and a member of the Trust
- 17 Territory Personnel Board; and
- 18 WHEREAS, from 1982-1990, the late Honorable Camillo Noket
- 19 worked for the Micronesian Legal Services Corporation, including

serving as the Directing Attorney from 1986-1990; and 1 2 WHEREAS, the late Honorable Camillo Noket was a member of the First Chuuk State Constitutional Convention in 1988 where he 3 4 served as Chairman of the Civil Liberties and Traditions 5 Committee; and 6 WHEREAS, the late Honorable Camillo Noket served as the Chairman of the Civil Liberties and Traditions Committee for the 7 8 Second FSM Constitutional Convention in 1990; and 9 WHEREAS, in 2001, the late Honorable Camillo Noket was 10 a delegate of the Third FSM Constitutional Convention and served 11 on the Civil Liberties and Traditions Committee; and WHEREAS, in 2020, the late Honorable Camillo Noket was a 12 delegate of the Fourth FSM Constitutional Convention; and 13 WHEREAS, in 1990, the late Honorable Camillo Noket's career 14 15 in the FSM National Government began with his employment as an Assistant Attorney General with the Office of Attorney General 16 Division of International Law and he was appointed as the FSM 17 18 Attorney General from 1992-1998; and 19 WHEREAS, the late Honorable Camillo Noket was an Associate Justice of the Chuuk State Supreme Court from 1998-1999; and 20 21 WHEREAS, from 1999-2006, the late Honorable Camillo Noket was again the Directing Attorney of the Micronesia Legal 22 23 Services Corporation in Chuuk; and WHEREAS, in 2019, the late Honorable Camillo Noket was the 24

President of the Pacific Judicial Council; and
