WHEREAS, section 104 of title 55 of the Code of the 2 Federated States of Micronesia (Annotated), as amended, requires that Congress adopt a resolution setting forth the total funds estimated to be available from the General Fund and any special funds estimated of the Treasury of the Federated 5 States of Micronesia for each fiscal year; now, therefore, BE IT RESOLVED by the Twenty-First Congress of the 7 Federated States of Micronesia, Second Special Session, 2019, that the amount estimated to be available for the fiscal year ending September 30, 2019, is set at \$151,656,879 of which \$149,044,256 is from domestic revenues, and \$1,000,000 will be 11 available from the Amended Compact sector grant and \$1,612,623 12 will be available from the Supplemental Education Grant; and 13 14 15 16 17 18 19
