DECLARING THE GOAL OF THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA TO HAVE THE FSM REACH UNIVERSAL HEALTH COVERAGE BY 2030 AND CALLING UPON THE PRESIDENT TO TAKE MEASURES TO EFFECTUATE THAT GOAL.

A RESOLUTION

Declaring the goal of the Congress of the Federated States of Micronesia to have the FSM reach Universal Health Coverage by 2030 and calling upon the President to take measures to effectuate that goal.

- WHEREAS, the principle of Universal Health Coverage ("UHC")
- 2 means that all people have access to the health services they need
- 3 when and where they need them, without financial hardship; and
- WHEREAS, UHC is a recognition of health care as a human
- 5 right; and
- 6 WHEREAS, on September 23, 2019, the United Nations General
- 7 Assembly held a high level meeting which issued a Political
- 8 Declaration which stated inter alia the goal of the United Nations
- 9 to "Ensure that no one is left behind, with an endeavor to reach
- 10 the furthest behind first, founded on the dignity of the human
- 11 person and reflecting the principles of equality and non-
- 12 discrimination, as well as to empower those who are vulnerable or
- 13 in vulnerable situations and address their physical and mental
- 14 health needs which are reflected in the 2030 Agenda for
- 15 Sustainable Development, including all children, youth, persons
- 16 with disabilities, people living with HIV/AIDS, older persons,
- 17 indigenous peoples, refugees and internally displaced persons and
- 18 migrants"; and
