representatives from the FSM Department of Resources and Development, the FSM Department of Transportation, Communications and Infrastructure, the FSM Department of Finance and Administration, the FSM Department of Justice, and the Office of the President.

At the hearing, there was a misunderstanding of the assignment of the measure. Nevertheless, your Committee heard from a representative from the Project Management Unit, Mr. Robert Goodwin.

According to Robert Goodwin, the funding is for the improvement of the water system and the sewer system in the state of Chuuk. Mr. Goodwin explained that the main objective of the project is to find a new source of water supply and improve the existing sewer system. According to Mr. Goodwin, there will be an extension of sewage pipes to hook up 750 households. Furthermore, the enhancement of technical assistance to Chuuk Power Utility Corporation (CPUC), but the PMU at the National Government will be monitoring the project. It was discussed at the hearing that CPUC has already come up with the plan and scope of the project.

Your Committee had asked why the funding is going to Chuuk State? Mr. Goodwin indicted that ADB also has plans on a water project in Kosrae, but Kosrae is not ready. Since CPUC has good management now, thus ADB has decided to give the project to CPUC based on its readiness. For Yap and Pohnpei states, ADB has already funded projects in Yap and Pohnpei states.

Your Committee was informed that the project is actually based on the readiness of CPUC to implement the project.
