

A BILL FOR AN ACT

To amend Public Law No. 21-157, as amended by Public Law No. 21-179, by amending sections 4 and 6 thereof, for the purpose of changing the use and allottee of funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 21-157 is hereby  
2 amended to read as follows:

3 "Section 4. Of the \$2,100,000 appropriated under  
4 this act, \$600,000 shall be apportioned to fund  
5 public projects and social programs for the people of  
6 Pohnpei State.

14 Section 2. Section 6 of Public Law No. 21-157 is hereby  
 15 amended to read as follows:

16 "Section 6. Allotment and management of funds and  
 17 lapse date. All funds appropriated by this act shall  
 18 be allotted, managed, administered and accounted for in  
 19 accordance with applicable laws, including, but not  
 20 limited to, the Financial Management Act of 1979. The  
 21 allottee shall be responsible for ensuring that these  
 22 funds, or so much thereof as may be necessary, are used  
 23 solely for the purpose specified in this act, and that  
 24 no obligations are incurred in excess of the sum  
 25 appropriated. The allottee of the funds appropriated

1 under section 2 of this act shall be the Governor of  
2 Yap or his designee. The allottee of the funds  
3 appropriated under subsection 3(1) of this act shall be  
4 the Governor of Kosrae or his designee. The allottee  
5 of the funds appropriated under subsection 3(2) of this  
6 act shall be the Mayor of Lelu Town Government or his  
7 designee. The allottee of the funds appropriated under  
8 section 4 of this act shall be the President of the  
9 Federated States of Micronesia or his designee;  
10 PROVIDED THAT, the allottee of funds appropriated under  
11 subsection 4(1)(a) of this act shall be the Pohnpei  
12 State Department of Land and Survey; the allottee of  
13 funds appropriated under subsection 4(1)(b) of this act  
14 shall be the Pohnpei Utility Corporation; the allottee  
15 of funds appropriated under subsection 4(1)(e) of this  
16 act shall be the Pohnpei Port Authority; the allottee  
17 of fund appropriated under subsections 4(1)(f),  
18 4(2)(a), 4(2)(b), 4(2)(c), 4(2)(e), 4(2)(f), 4(2)(g),  
19 4(2)(h), and 4(2)(i) of this act shall be the Secretary  
20 of the Department of Transportation, Communications and  
21 Infrastructure or his designee;" the allottee of funds  
22 appropriated under subsection 4(2)(d) of this act shall  
23 be the Mayor of Kolonia Town Government or his  
24 designee; the allottee of funds appropriated under  
25 subsections 4(1)(c), 4(1)(d), 4(3)(a), 4(3)(b) and

1           4(3)(c) of this act shall be the Pohnpei Transportation  
2 Authority; the allottee of funds appropriated under  
3 subsection 4(3)(d) of this act shall be the Chief  
4 Justice of Kitti or his designee. The allottee of the  
5 funds appropriated under subsections 5(1) and 5(6) of  
6 this act shall be the Governor of Chuuk State or his  
7 designee; the allottee of the funds appropriated under  
8 subsection 5(2) of this act shall be the Mortlocks  
9 Island Development Authority (MIDA); the allottee of  
10 the funds appropriated under subsection 5(3) of this  
11 act shall be the Mayor of Weno Municipal Government or  
12 his designee; the allottee of the funds appropriated  
13 under subsection 5(4) of this act shall be the Southern  
14 Namoneas Development Authority; the allottee of the  
15 funds appropriated under subsection 5(5) of this act  
16 shall be the Faichuk Development Authority. The  
17 authority of the allottee to obligate funds  
18 appropriated by this act shall lapse on September 30,  
19 2022.

20           Section 3. This act shall become law upon approval by the  
21 President of the Federated States of Micronesia or upon its  
22 becoming law without such approval.
