

A BILL FOR AN ACT

To appropriate the sum of \$7,000,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2021, for the purpose of funding priority infrastructure projects and other public projects in the states of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$7,000,000, or so much thereof as may
2 be necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending
4 September 30, 2021, for the purpose of funding priority
5 infrastructure projects and other public projects in the states of
6 Yap, Kosrae, Pohnpei and Chuuk. The funds appropriated under this
7 section shall be apportioned as follows:

8 Section 2. Of the \$7,000,000 appropriated under this act,
9 \$770,000 shall be apportioned for priority infrastructure
10 projects and other public projects in the state of Yap.

12 Section 3. Of the \$7,000,000 appropriated under this act,
13 \$490,000 shall be apportioned for priority infrastructure projects
14 and other public projects in the state of Kosrae.

1 Section 4. Of the \$7,000,000 appropriated under this act,
 2 \$2,450,000 shall be apportioned for priority infrastructure
 3 projects and other public projects in the state of Pohnpei.

9 Section 5. Of the \$7,000,000 appropriated under this act,
 10 \$3,290,000 shall be apportioned for priority infrastructure projects
 11 and other public projects in the state of Chuuk.

19 Section 6. Allotment and management of funds and lapse date.
 20 All funds appropriated by this act shall be allotted, managed,
 21 administered and accounted for in accordance with applicable laws,
 22 including, but not limited to, the Financial Management Act of
 23 1979. The allottee shall be responsible for ensuring that these
 24 funds, or so much thereof as may be necessary, are used solely for
 25 the purpose specified in this act, and that no obligations are

1 incurred in excess of the sum appropriated. The allottee of the
2 funds appropriated under section 2 of this act shall be the
3 Governor of Yap State or his designee. The allottee of funds
4 appropriated under sections 3 and 4 of this act shall be the
5 President of the Federated States of Micronesia or his designee;
6 The allottee of the funds appropriated under subsections 5(1) and
7 5(6) of this act shall be the Governor of Chuuk State or his
8 designee; the allottee of the funds appropriated under subsection
9 5(2) of this act shall be the Mortlocks Island Development
10 Authority (MIDA), the allottee of funds appropriated under section
11 5(3) of this act shall be the Mayor of Weno Municipal Government
12 or his designee; the allottee of the funds appropriated under
13 subsection 5(4) of this act shall be the Southern Namoneas
14 Development Authority; the allottee of the funds appropriated
15 under subsection 5(5) of this act shall be the Faichuk Development
16 Authority. The authority of the allottee to obligate funds
17 appropriated by this act shall lapse on September 30, 2023.

18 Section 7. This act shall become law upon approval by the
19 President of the Federated States of Micronesia or upon its
20 becoming law without such approval.
