

A BILL FOR AN ACT

To further amend Public Law No. 21-201, as amended by Public Law No. 21-219, by amending section 3 thereof, for the purpose of changing the use of funds previously appropriated therein, to fund priority infrastructure projects and other public projects and social programs for the people of Kosrae state, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 21-201 is hereby
2 amended to read as follows:

3 "Section 3. Of the \$8,400,000 appropriated under this
4 act, \$1,200,000 shall be apportioned for priority
5 infrastructure projects and other public projects and
6 social programs for the people of Kosrae State.
