
A RESOLUTION

A RESOLUTION

Approving and accepting a grant in the amount of \$420,946 from the U.S. Department of Interior, National Park Services, to provide historic preservation funding to support the FSM Office of National Archives, Culture and Historic Preservation, including all the terms and conditions of the assistance.

1 WHEREAS, a grant has been awarded to the FSM Office of
2 National Archives, Culture and Historic Preservation from the
3 United States Department of Interior, National Park Services, in
4 the amount of \$420,946; and

5 WHEREAS, the purpose of this grant is to fund the FSM Office
6 of National Archives, Culture and Historic Preservation in the
7 protection and conservation of state, territorial and local
8 cultural and historic assets and to assist in the executing of its
9 historic preservation programs and activities in the FSM; and

10 WHEREAS, section 210(2) of title 55 of the Code of the
11 Federated States of Micronesia (Annotated), as amended, requires
12 that for foreign financial assistance to be valid it must be
13 approved by Congress by resolution; now, therefore,

14 BE IT RESOLVED by the Twenty-First Congress of the Federated
15 States of Micronesia, Fifth Special Session, 2020, that Congress
16 hereby approves and accepts the grant in the amount of \$420,946 to
17 fund the FSM Office of National Archives, Culture and Historic
18 Preservation, including all the terms and conditions thereof; and


1 BE IT FURTHER RESOLVED that certified copies of this


