A RESOLUTION

Approving and accepting a grant from the World Health Organization in the amount of \$1,500,000, to fund and support the various health and social programs in the FSM, and to carry out the Joint Work Plan with the World Health Organization, including all the terms and conditions of the assistance.

1 WHEREAS, upon request from the Federated States of
2 Micronesia, the World Health Organization extended to the
3 Government of the Federated States of Micronesia a grant in the
4 amount of \$1,500,000, as evidenced by the attached letter dated
5 November 06, 2019; and

6 WHEREAS, the purpose of the grant is to provide the essential
7 funding and support for the implementation of the various health
8 and social programs in the FSM and to carry out the Joint Work
9 Plan and its activities with the World Health Organization; and

10 WHEREAS, section 210(2) of title 55 of the Code of the
11 Federated States of Micronesia (Annotated), as amended, provides
12 that for an agreement on foreign financial assistance to be valid
13 it must be approved by Congress by resolution; now, therefore,

14 BE IT RESOLVED by the Twenty-First Congress of the Federated
15 States of Micronesia, Fifth Special Session, 2020, that Congress
16 hereby approves and accepts the grant in the amount of \$1,500,000
17 from the World Health Organization, to fund the various health and
18 social programs in the FSM and to carry out the Joint Work Plan
19 with the World Health Organization, including all the terms and
20 conditions thereof; and

1 BE IT FURTHER RESOLVED that certified copies of this
2 resolution be transmitted to the President of the Federated States
3 of Micronesia, the Secretary of the Department of Health and
4 Social Affairs and the Secretary of the Department of Foreign
5 Affairs.
