A RESOLUTION

Approving and accepting a grant in the amount of \$368,300 from the U.S. Department of Health and Human Services, Public Health Services Administration, to support and fund the FSM Department of Health and Social Affairs Family Planning Program, including all the terms and conditions of the assistance.

1 WHEREAS, on March 18, 2020, the United States through the
2 Department of Health and Human Services, Public Health Services
3 Administration, issued a Notice of Award in the amount of
4 \$368,300, to fund and support the FSM Family Planning Program and
5 its services for the budget period from April 01, 2020 to March
6 31, 2021; and

7 WHEREAS, the purpose of this grant is to fund and support the
8 implementation of the FSM Family Planning Program, to ensure
9 accessibility of effective contraceptive of choice to improve the
10 overall health status of women of child bearing age in the FSM;
11 and

12 WHEREAS, section 210(2) of title 55 of the Code of the
13 Federated States of Micronesia (Annotated), as amended, requires
14 that for foreign financial assistance to be valid it must be
15 approved by Congress by resolution; now, therefore,


16 BE IT RESOLVED by the Twenty-First Congress of the Federated
17 States of Micronesia, Fifth Special Session, 2020, that Congress
18 hereby approves and accepts the \$368,300 grant from the U.S.
19 Department of Health and Human Services, Public Health Services
20 Administration, to fund the FSM Family Planning Program, including

1 all the terms and conditions thereof; and


2 BE IT FURTHER RESOLVED that certified copies of this
