A RESOLUTION

To allocate \$5,000,000 from the People's Republic of China grants to the Federated States of Micronesia, to fund road improvements in Kosrae State.

1 WHEREAS, China has designated millions of dollars in
2 grant funding to the Federated States of Micronesia for the
3 purpose of road improvements; and

4 WHEREAS, under such program, Kosrae State was allocated
5 over \$5,000,000 million but the project was never
6 consummated or implemented; and

7 WHEREAS the roads in Kosrae have been in need of
8 improvement; now, therefore,

9 BE IT RESOLVED by the Twenty-First Congress of the Federated
10 States of Micronesia, Fourth Special Session, 2020, that Congress
11 hereby requests that \$5,000,000 of the People's Republic of China
12 grant money be made available to the state of Kosrae for road
13 improvements within the state of Kosrae; and


