A RESOLUTION

To approve and accept a grant in the amount of \$235,000 from the U.S. Department of Health and Human Services, Health Resources and Services Administration (HRSA), to support and fund the Universal Newborn Hearing Screening and Intervention Project, including all the terms and conditions of the assistance.

1           WHEREAS, on March 04, 2020, the United States through the  
2 Department of Health and Human Services, Health Resources and  
3 Services Administration (HRSA), issued the Notice of Award for  
4 financial assistance in the amount \$235,000, to fund and support  
5 the project entitled: "Universal Newborn Hearing Screening and  
6 Intervention" for the budgeted period from April 01, 2020, to March  
7 31, 2021; and

8           WHEREAS, the purpose of this grant is to fund and support the  
9 implementation of the Universal Newborn Hearing Screening and  
10 Intervention Project and its related activities; and

11           WHEREAS, section 210(2) of title 55 of the Code of the  
12 Federated States of Micronesia (Annotated), as amended, requires  
13 that for foreign financial assistance to be valid it must be  
14 approved by Congress by resolution; now, therefore,

15           BE IT RESOLVED by the Twenty-First Congress of the Federated  
16 States of Micronesia, Fifth Special Session, 2020, that Congress  
17 hereby approves and accepts the \$235,000 grant from the U.S.  
18 Department of Health and Human Services, Health Resources and  
19 Services Administration, to fund the Universal Newborn Hearing  
20 Screening and Intervention Project; and


1 BE IT FURTHER RESOLVED that certified copies of this
