Approving and accepting a grant from the United Nations Children's Fund (UNICEF) in the amount of \$28,868, to fund and support the implementation of the FSM Sustainable Development Goal's Voluntary National Review (VNR) Report, including all the terms and conditions of the assistance.

1           WHEREAS, the United Nations Children's Fund (UNICEF) issued a  
2 notification letter of funds transferred to the Federated States  
3 of Micronesia on March 10, 2020, to the Department of Health and  
4 Social Affairs, in the amount of \$28,868; and

5           WHEREAS, the purpose of this grant is to fund and support the  
6 implementation of the Voluntary National Review (VNR) Report of  
7 the nation; and

8           WHEREAS, section 210(2) of title 55 of the Code of the  
9 Federated States of Micronesia (Annotated), as amended, requires  
10 that for foreign financial assistance to be valid it must be  
11 approved by Congress by resolution; now, therefore,

12           BE IT RESOLVED by the Twenty-First Congress of the Federated  
13 States of Micronesia, Fifth Special Session, 2020, that Congress  
14 hereby approves the grant in the amount of \$28,868 from UNICEF, to  
15 provide funding support for the implementation of the FSM  
16 Sustainable Development Goals's VNR Report and its activities,  
17 including all the terms and conditions thereof; and




