A RESOLUTION

Approving and accepting a grant in the amount of \$397,192 from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention, to support and fund the Tobacco Control and Diabetes Prevention Program I in the FSM, including all the terms and conditions of the assistance.

1 WHEREAS, on March 13, 2019, the United States through the
2 Department of Health and Human Services, Centers for Disease
3 Control and Prevention, extended to the Government of the
4 Federated States of Micronesia a grant in the amount of \$397,192
5 as evidenced by a Notice of Grant No. NU58DPO06667-01-00; and

6 WHEREAS, the grant was awarded for the specific purpose of
7 funding the project entitled: "Prevention and Control of Chronic
8 Disease and Associated Risk Factors in the Nation" for the budget
9 period from March 29, 2019, to March 28, 2020, to be managed and
10 implemented by the FSM Department of Health and Social Affairs,
11 Tobacco Control and Diabetes Prevention Program; and

12 WHEREAS, section 210(2) of title 55 of the Code of the
13 Federated States of Micronesia (Annotated), as amended, provides
14 that for foreign financial assistance to be valid it must be
15 approved by Congress by resolution; now, therefore,

16 BE IT RESOLVED by the Twenty-First Congress of the Federated
17 States of Micronesia, First Regular Session, 2019, that Congress
18 hereby approves and accepts the \$397,192 grant from the U.S.
19 Department of Health and Human Services, Centers for Disease
20 Control and Prevention, to fund the FSM Tobacco Control and

1 Diabetes Prevention Program I, including all the terms and
2 conditions thereof; and

3 BE IT FURTHER RESOLVED that certified copies of this
4 resolution be transmitted to the President of the Federated States
5 of Micronesia, the Secretary of the Department of Health and
6 Social Affairs and the United States Embassy in Kolonia.


