A RESOLUTION

Approving and accepting a grant in the amount of \$130,120 from the United Nations Population Fund, to provide funding support for the implementation of the FSM's programs under the UNFPA Strategic Plan 2018-2021, including all the terms and conditions of the assistance.

1           WHEREAS, the United Nations Population Fund extended to the  
2 Government of the Federated States of Micronesia a grant in the  
3 amount of \$130,120 as evidenced by the attached FSM's 2019 Work  
4 Plan with the FSM Department of Health and Social Affairs signed  
5 on April 18, 2019; and

6           WHEREAS, the purpose of the grant is to fund and support the  
7 implementation of the allocated programs in the 2019 Work Plan for  
8 the FSM targeting specifically: 1) Integrated sexual and  
9 reproductive health services, 2) Community and school based family  
10 life education programs, 3) Gender equality and the empowerment of  
11 women and girls, 4) Health sector response to violence against  
12 women and girls, 5) Availability analysis, and utilization of  
13 ICPD/SDG-related data, and 6) Data use for policy and advocacy;

15           WHEREAS, section 210(2) of title 55 of the Code of the  
16 Federated States of Micronesia (Annotated), as amended, provides  
17 that for foreign financial assistance to be valid it must be  
18 approved by Congress by resolution; now, therefore,


19           BE IT RESOLVED by the Twenty-First Congress of the Federated

21 hereby approves and accepts the \$130,120 grant from the United

3 conditions thereof; and


4 BE IT FURTHER RESOLVED that certified copies of this
