A RESOLUTION

Approving and accepting a grant in the amount of \$387,833 from the U.S. Department of Health and Human Services, Health Resources and Services Administration, to fund and support the Maternal and Child Health Services Program in the FSM, including all the terms and conditions of the assistance.

1 WHEREAS, on April 09, 2019, the United States through the
2 Department of Health and Human Services, Health Resources and
3 Services Administration, extended to the Government of the
4 Federated States of Micronesia a grant in the amount of \$387,833
5 as evidenced by a Notice of Grant No. B04MC32540-01-02; and

6 WHEREAS, the grant was awarded for the specific purpose of
7 funding the FSM Maternal and Child Health Services Program for the
8 improvement of mothers and childrens health in the FSM; and

9 WHEREAS, section 210(2) of title 55 of the Code of the
10 Federated States of Micronesia (Annotated), as amended, provides
11 that for foreign financial assistance to be valid it must be
12 approved by Congress by resolution; now, therefore,

13 BE IT RESOLVED by the Twenty-First Congress of the Federated
14 States of Micronesia, First Regular Session, 2019, that Congress
15 hereby approves and accepts the \$387,833 grant from the U.S.
16 Department of Health and Human Services, Health Resources and
17 Services Administration, to fund the FSM Maternal and Child Health
18 Services Program, including all the terms and conditions thereof;

4 Social Affairs, and the United States Embassy in Kolonia.




