Approving and accepting a grant in the amount of \$4,248,000 from the U.S. Federal Aviation Administration (FAA), to provide funding for the Yap International Airport Project, including all the terms and conditions.

1 WHEREAS, the U.S. FAA has approved a federal funding
2 application for the airport development in Yap, particularly to
3 improve airfield miscellaneous improvements and airfield light
4 vault construction which was lodged with the U.S Federal Aviation
5 Administration on July 12, 2019; and

6 WHEREAS, the total amount of money approved is \$4,248,000;
7 and

8 WHEREAS, section 210(2) of title 55 of the Code of the
9 Federated States of Micronesia (Annotated), as amended, requires
10 that for foreign financial assistance to be valid it must be
11 approved by Congress by resolution; now, therefore,

12 BE IT RESOLVED by the Twenty-First Congress of the Federated
13 States of Micronesia, Third Regular Session, 2020, that Congress
14 hereby approves and accepts the \$4,248,000 grant from the U.S.
15 Federal Aviation Administration, to fund the Yap International
16 Airport Project, including all the terms and conditions thereof;


1 BE IT FURTHER RESOLVED that certified copies of this
