1 WHEREAS, on July 19, 2019, the U.S. Department of Health and
2 Human Services, Health Resources and Services Administration,
3 issued a Grant Award in the total amount of \$129,645 to fund the
4 FSM Maternal and Child Health Program; and

5 WHEREAS, the purpose of this grant is to fund, assist and
6 improve the health of women and children in the FSM; and

7 WHEREAS, section 210(2) of title 55 of the Code of the
8 Federated States of Micronesia (Annotated), as amended, provides
9 that for foreign financial assistance to be valid, it must be
10 approved by Congress by resolution; now, therefore,

11 BE IT RESOLVED by the Twenty-First Congress of the Federated
12 States of Micronesia, Third Regular Session, 2020, that Congress
13 hereby approves and accepts the grant in the amount of \$129,645
14 from the U.S. Department of Health and Human Services, Health and
15 Resources Services Administration, to fund the FSM Maternal and
16 Child Health Program, including all the terms and conditions
17 thereof; and


