A RESOLUTION

Approving and accepting a grant in the amount of \$102,640 from the United Nations International Children's Emergency Fund, to fund and support the Measles Outbreak Responses Program in the FSM from the funding period of January to March 2020, including all the terms and conditions of the assistance.

1 WHEREAS, on December 24, 2019, the United Nations
2 International Children's Emergency Fund issued a notice of
3 funding authorization and certificate of expenditure in the
4 amount of \$102,640 to fund and assist the Measles Outbreak
5 Response Program in the FSM; and

6 WHEREAS, the purpose of this grant is to assist the FSM
7 Department of Health and Social Affairs in preventing and
8 responding to the measles outbreak; and

9 WHEREAS, section 210(2) of title 55 of the Code of the
10 Federated States of Micronesia (Annotated), as amended,
11 requires that for foreign financial assistance to be valid it
12 must be approved by Congress by resolution; now, therefore,

13 BE IT RESOLVED by the Twenty-First Congress of the
14 Federated States of Micronesia, Third Regular Session, 2020,
15 that Congress hereby approves and accepts the \$102,640 grant
16 from the United Nations International Children's Emergency
17 Fund, to fund the Measles Outbreak Response Program in the FSM,
18 including all the terms and conditions thereof; and

1 BE IT FURTHER RESOLVED that certified copies of the
2 resolution be transmitted to the President of the Federated
3 States of Micronesia, the Secretary of the Department of Health
4 and Social Affairs and the Secretary of the Department of
5 Foreign Affairs.


