A RESOLUTION

To confirm the nomination of Secretary Eugene Amor to serve as a representative of the FSM Government to the Joint Trust Fund Committee.

1 WHEREAS, pursuant to Public Law No. 15-70 the President is
2 authorized to appoint two representatives to the Joint Trust
3 Fund Committee, one from a position within the FSM National
4 government related to law or finance, and the other one will be
5 from the private sector with at least five years of working
6 experience in financial management and investment; and

7 WHEREAS, the nomination is subject to the advice and
8 consent of Congress pursuant to Public Law No. 15-70, section
9 3(1); and

10 WHEREAS, the President has nominated Secretary Eugene Amor
11 to represent the FSM Government on the Joint Trust Fund
12 Committee as a representative; and

13 WHEREAS, Secretary Eugene Amor is qualified to serve on
14 the Joint Trust Fund Committee based on his educational
15 attainment and professional experience; now, therefore,

16 BE IT RESOLVED by the Twenty-First Congress of the
17 Federated States of Micronesia, Fourth Special Session, 2020,
18 that Congress hereby confirms the nomination of Secretary
19 Eugene Amor to serve as a representative of the FSM Government
20 to the Joint Trust Fund Committee; and


1 BE IT FURTHER RESOLVED that certified copies of the
