A RESOLUTION

Approving and accepting a grant in the amount of \$385,725 from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention, to support and fund the Comprehensive Cancer Control Program and its services in the FSM, including all the terms and conditions of the assistance.

1 WHEREAS, on April 30, 2019, the United States through the
2 Department of Health and Human Services, Centers for Disease
3 Control and Prevention, extended to the Government of the
4 Federated States of Micronesia a grant in the amount of \$385,725
5 as evidenced by a Notice of Grant No. NU58DPO06303-03-00; and

6 WHEREAS, the grant was awarded for the specific purpose of
7 funding the project entitled: "FSM Comprehensive Cancer Control
8 Program in Implementing the FSM's CCC Plan to Reduce Cancer Burden
9 in the FSM" for the budget period from June 30, 2019, to June 29,
10 2020, to be managed and implemented by the FSM Department of
11 Health and Social Affairs, Comprehensive Cancer Control Program;

13 WHEREAS, section 210(2) of title 55 of the Code of the
14 Federated States of Micronesia (Annotated), as amended, provides
15 that for foreign financial assistance to be valid it must be
16 approved by Congress by resolution; now, therefore,

17 BE IT RESOLVED by the Twenty-First Congress of the Federated
18 States of Micronesia, First Regular Session, 2019, that Congress
19 hereby approves and accepts the \$385,725 grant from the U.S.
20 Department of Health and Human Services, Centers for Disease

1 Control and Prevention, to fund the Comprehensive Cancer Control
2 Program and its services in the FSM, including all the terms and
3 conditions thereof; and


4 BE IT FURTHER RESOLVED that certified copies of this
