9           WHEREAS, Mr. Anefal is currently the charge d' Affaires in  
10 the FSM Mission to Beijing and is an experienced and competent  
11 diplomatic staff; and

12           WHEREAS, Mr. Anefal is qualified to serve as the Deputy  
13 Chief of Mission to the FSM Embassy in the People's Republic of  
14 China; now, therefore,

15           BE IT RESOLVED by the Twenty-First Congress of the  
16 Federated States of Micronesia, Fourth Special Session, 2020,  
17 that Congress hereby confirms the nomination of Mr. Francis  
18 Anefal to serve as the Deputy Chief of Mission to the FSM  
19 Embassy in the People's Republic of China; and

4 and Mr. Francis Anefal.


