A RESOLUTION

To approve and accept of grant in the amount \$100,220 from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention, to fund the FSM Preventive Health and Health Services Block Grant 2019, including all the terms and conditions of the assistance.

1 WHEREAS, the U.S. Department of Health and Human Services,
2 Centers for Disease Control and Prevention, issued a Grant Award
3 on August 29, 2019, to the Government of the Federated States of
4 Micronesia providing funding in the amount of \$100,220 for the
5 purpose of providing support to the FSM Preventive Health and
6 Health Services Block Grant 2019; and

7 WHEREAS, section 210(2) of title 55 of the Code of the
8 Federated States of Micronesia (Annotated), as amended, provides
9 that for foreign financial assistance to be valid it must be
10 approved by Congress by resolution; now, therefore,

11 BE IT RESOLVED by the Twenty-First Congress of the Federated
12 States of Micronesia, Third Regular Session, 2020, that Congress
13 hereby approves and accepts the \$100,220 grant from the U.S.
14 Department of Health and Human Services, Centers for Disease
15 Control and Prevention, to provide funding for the FSM
16 Preventative Health and Health Services Block Grant 2019,
17 including all the terms and conditions thereof; and


