APPROVING AND ACCEPTING A GRANT IN THE AMOUNT OF \$412,163 FROM THE U.S. DEPARTMENT OF INTERIOR, NATIONAL PARK SERVICE, USING FUNDS FROM THE HISTORIC PRESERVATION FUND UNDER U.S. PUBLIC LAW, INCLUDING ALL THE TERMS AND CONDITIONS OF THE ASSISTANCE.

A RESOLUTION

Approving and accepting a grant in the amount of \$412,163 from the U.S. Department of Interior, National Park Service, using funds from the Historic Preservation Fund under U.S. public law, including all the terms and conditions of the assistance.

1 WHEREAS, U.S. Department of Interior, National Park Service,
2 issued a Notice of Award of financial assistance on April 11,
3 2019, in the amount of \$412,163; and

4 WHEREAS, the purpose of the grant is to support historic
5 preservation agencies at the national and state levels across the
6 Nation, and for this purpose, an amount of up to \$146,500 is for
7 the Pohnpei State Historic Preservation Office, the amount of
8 \$139,500 is for the Yap State Historic Preservation Office, the
9 amount of \$53,000 is for the FSM National Historic Preservation
10 Office, and the amount of \$73,163 is for the Kosrae State Historic
11 Preservation Office; and

12 WHEREAS, section 210(2) of title 55 of the Code of the
13 Federated States of Micronesia (Annotated), as amended, provides
14 that for an agreement on foreign financial assistance to be valid
15 it must be approved by Congress by resolution; and

16 WHEREAS, that the FSM Government expresses appreciation to
17 the United States Government for the federal grant programs made
18 available to the Federated States of Micronesia; now, therefore,


19 BE IT RESOLVED by the Twenty-First Congress of the Federated
20 States of Micronesia, First Special Session, 2019, that Congress
21 hereby approves and accepts the \$412,163 grant from the U.S.

1 Department of Interior subject to the allocation above, including
2 all the terms and conditions thereof; and

3 BE IT FURTHER RESOLVED that certified copies of this
4 resolution be transmitted to the President of the Federated States
5 of Micronesia, the Director of the Office of National Archives,
6 Culture & Historic Preservation and the United States Embassy in
7 Kolonia.


