6 rejected, and its reconsideration has also failed, and under 2  
7 F.S.M.C.§207(3) the nomination may not be resubmitted by the  
8 President during the Twenty-First Congress without  
9 authorization by Congress; now, therefore,

10           BE IT RESOLVED by the Twenty-First Congress of the  
11 Federated States of Micronesia, Fourth Regular Session, 2020,  
12 that Congress hereby authorizes the President to resubmit the  
13 nomination of Mr. Kasio E. Mida to serve as a member of the  
14 Federated States of Micronesia Insurance Board; and
