A RESOLUTION

Giving advice and consent, pursuant to Article XI, Section 3, of the Constitution of the Federated States of Micronesia, to the appointment of Mr. Dennis L. Belcourt, to serve as an Associate Justice of the Supreme Court of the Federated States of Micronesia.

1           WHEREAS, the President of the Federated of Micronesia has  
2 nominated Mr. Dennis L. Belcourt to serve as an Associate Justice  
3 of the Federated States of Micronesia Supreme Court; and

4           WHEREAS, the nomination and appointment is subject to the  
5 advice and consent of Congress pursuant to section 3 of Article XI  
6 of the Constitution of the Federated States of Micronesia; and

7           WHEREAS, Mr. Belcourt has extensive experience in public  
8 service both in the United States and in the Federated States of  
9 Micronesia, including his service as Deputy Attorney General in  
10 Nevada, USA, Legislative Counsel of the FSM Congress, and as legal  
11 counsel of the Kosrae State Legislature; and

12           WHEREAS, Mr. Belcourt is qualified to serve as an Associate  
13 Justice of the Supreme Court; now, therefore,

14           BE IT RESOLVED by the Twenty-First Congress of the Federated  
15 States of Micronesia, Sixth Special Session, 2020, that Congress  
16 hereby gives its advice and consent to the nomination and  
17 appointment of Mr. Dennis L. Belcourt to serve as an Associate  
18 Justice of the Supreme Court of the Federated States of Micronesia;  
19 and

1 BE IT FURTHER RESOLVED that certified copies of this  
2 resolution be transmitted to the President of the Federated States  
3 of Micronesia, the Governor of each state of the Nation, and to Mr.  
4 Dennis L. Belcourt.
