A RESOLUTION

Approving and accepting a grant in the amount of \$250,000 from the U.S. Department of Health and Human Services, Administration for Children and Families, to fund and support the Personal Responsibility Education Program in the FSM, including all the terms and conditions of the assistance.

1           WHEREAS, on April 16, 2020, the U.S. Department of Health and  
2 Human Services, Administration for Children and Families, issued a  
3 Notice of Grant Award in the amount of \$250,000 to the Federated  
4 States of Micronesia, Department of Health and Social Affairs, to  
5 fund and support the Personal Responsibility Education Program in  
6 the FSM, and

7           WHEREAS, the purpose of the grant is to provide funding for  
8 the early intervention for teens ages 15-19, to address unhealthy,  
9 risky behaviors such as early pregnancy, incomplete educational  
10 goals and negative peer pressure under the Personal Responsibility  
11 Education Program; and

12           WHEREAS, section 210(2) of title 55 of the Code of the  
13 Federated States of Micronesia (Annotated), as amended, requires  
14 that for foreign financial assistance to be valid it must be  
15 approved by Congress by resolution; now, therefore,

16           BE IT RESOLVED by the Twenty-First Congress of the Federated  
17 States of Micronesia, Fourth Regular Session, 2020, that Congress  
18 hereby approves and accepts the \$250,000 grant from the U.S.  
19 Department of Health and Human Services, Administration for  
20 Children and Families, to fund the Personal Responsibility

1 Education Program in the FSM, including all the terms and  
2 conditions thereof; and

3 BE IT FURTHER RESOLVED that certified copies of this  
4 resolution be transmitted to the President of the Federated States  
5 of Micronesia, the Secretary of the Department of Health and  
6 Social Affairs and the Secretary of the Department of Foreign  
7 Affairs.




