A RESOLUTION

Approving and accepting grants in the total amount of \$525,042 from the U.S. Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, to provide funding for prevention and treatment services related to substance abuse for the budget period from October 01, 2020, to September 30, 2021, including all the terms and conditions of the assistance.

1 WHEREAS, the United States through the Department of Health
2 and Human Services, Substance Abuse and Mental Health Services
3 Administration, issued two (2) separate Notices of Awards on April
4 21, 2020, and May 15, 2020, in the total amount of \$525,042, and

5 WHEREAS, the purpose of the grants are to provide funding to
6 support, plan, implement, and evaluate activities that prevent and
7 treat substance abuse; and

8 WHEREAS, section 210(2) of title 55 of the Code of the
9 Federated States of Micronesia (Annotated), as amended, requires
10 that for foreign financial assistance to be valid it must be
11 approved by Congress by resolution; now, therefore,

12 BE IT RESOLVED by the Twenty-First Congress of the Federated
13 States of Micronesia, Fourth Regular Session, 2020, that Congress
14 hereby approves and accepts the \$525,042 grant from the U.S.
15 Department of Health and Human Services, Substance Abuse and
16 Mental Health Services Administration, to provide funding for
17 prevention and treatment services related to substance abuse,
18 including all the terms and conditions thereof; and
