A RESOLUTION

Approving and accepting a grant in the amount of \$325,725 from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention (CDC), in order to provide funding support for the FSM Comprehensive Cancer Control Program, including all the terms and conditions of the assistance.

1 WHEREAS, on May 1, 2020, the United States Department of
2 Health and Human Services, Centers for Disease Control and
3 Prevention, issued a Notice of Award in the amount of \$325,725 to
4 fund the FSM Comprehensive Cancer Control Program; and

5 WHEREAS, section 210(2) of title 55 of the Code of the
6 Federated States of Micronesia (Annotated), as amended, requires
7 that for foreign financial assistance to be valid it must be
8 approved by Congress by resolution; and

9 WHEREAS, the government of the Federated States of Micronesia
10 expresses its appreciation to the United States Government for the
11 federal grant programs made available to the Federated States of
12 Micronesia, now, therefore,

13 BE IT RESOLVED by the Twenty-First Congress of the Federated
14 States of Micronesia, Sixth Special Session, 2020, that Congress
15 hereby approves and accepts the \$325,725 grant from the U.S.
16 Department of Health and Human Services, Centers for Disease
17 Control and Preventing, to fund the FSM Comprehensive Cancer
18 Control Program, including all the terms and conditions thereof;

6 U.S. Embassy in Kolonia.


