A RESOLUTION

Approving and accepting a grant in the amount of \$49,733.20 (Canadian Dollar) from the Government of Canada, in order to provide funding support to the Anti-Human Trafficking Program of the FSM Department of Justice, including all the terms and conditions of the assistance.

1 WHEREAS, on June 5, 2020, the Canadian Government through the
2 High Commission of Canada in Canberra advised that the Canadian
3 Government is proving funding in the amount of \$49,733.20
4 (Canadian Dollar) to support the Anti-Human Trafficking Program of
5 the FSM Department of Justice; and

6 WHEREAS, section 210(2) of title 55 of the Code of the
7 Federated States of Micronesia (Annotated), as amended, provides
8 that for foreign financial assistance to be valid it must be
9 approved by Congress by resolution; and

10 WHEREAS, the government of the Federated States of Micronesia
11 expresses its appreciation to the Canadian Government for this
12 funding, now, therefore,

13 BE IT RESOLVED by the Twenty-First Congress of the Federated
14 States of Micronesia, Seventh Special Session, 2020, that Congress
15 hereby approves and accepts the \$49,733.20 grant from the
16 Government of Canada to provide funding for the Anti-Human
17 Trafficking Program, including all the terms and conditions
18 thereof; and




