A RESOLUTION

Approving and accepting a grant in the amount of \$1,584,074 from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention (U.S. CDC), to fund the Year 2 FSM Immunization and Vaccines for Children Program, including all the terms and conditions of the assistance.

1           WHEREAS, the U.S. CDC issued a Grant Award on June 21, 2020,  
2 to the Government of the Federated States of Micronesia providing  
3 funding in the amount of \$1,584,074 for the purpose of providing  
4 support to the Year 2 FSM Immunization and Vaccines for Children  
5 Program;

6           WHEREAS, section 210(2) of title 55 of the Code of the  
7 Federated States of Micronesia (Annotated), as amended, provides  
8 that for foreign financial assistance to be valid it must be  
9 approved by Congress by resolution; and

10          WHEREAS, the government of the Federated States of Micronesia  
11 wishes to express its appreciation and gratitude to the U.S. CDC  
12 and the U.S. Government for extending this grant; and

13          BE IT RESOLVED by the Twenty-First Congress of the Federated  
14 States of Micronesia, Sixth Special Session, 2020, that Congress  
15 hereby approved and accepts the grant in the amount of \$1,584,074  
16 from the U.S. CDC, to fund the Year 2 FSM Immunizations and  
17 Vaccines for Children Program, including all the terms and  
18 conditions thereof; and


